### **Item No.3 Autonomous Colleges.**

The Governing Body approved the Report of the committee constituted to study the academic and other aspects of the functioning of Autonomous college in the state presented by Dr. Joy Job Kulavelil (Chairman) and also decided to forward the same to the Government.

Further resolved to include a nominee of a Research Institute in the Governing Body of Autonomous Colleges.

### **Item No.4 Open University.**

The Governing Body approved the Report of the committee constituted to draw the Implementation Procedure for the Institution of Open University in the state presented by Dr. Fathimathu Zuhara (Chair Person) and also decided to forward the same to the Government.

### **Item No.5 Draft Guidelines/ Norms for Equivalency/ Recognition of Degrees.**

The Governing Body meeting approved the Guidelines and Norms for Equivalency/ Recognition of Degrees (as given below) presented by the Chairman of the committee Prof. Rajan Gurukkal.

#### **Norms/Guidelines Relating to Equivalency/Recognition of Academic Programmes or Areas of Studies and Nomenclature and Degrees of Other Universities**

*In exercise of the powers conferred under by the Kerala State Higher Education Council Act, 2007(Act 22 of 2007), together with all the amendments made therein from time to time and amendment of section 4 , sub section(2), of clauses (zd) and (ze)*

*((zd)- evolve common academic guidelines for Universities in the State for mutual recognition, approval or equalization of academic programmes or areas of studies and nomenclature thereof;*

*(ze)-evolve common academic guidelines for Universities in the State for recognition, approval or equalization of academic programmes or areas of studies and nomenclature thereof of various programmes conducted by Universities or higher education institutions outside the State and outside the country);*

*of the Kerala State Higher Education Council, hereby, frames the following Norms & Guidelines, namely:-*

1. All universities, higher educational institutions (HEIs), agencies and employers shall recognize the degrees awarded by national institutes like Indian Institutes of Technology (IITs), Indian Institute of Science (IISc), National Institutes of Technology (NITs), Indian Institutes of Science Education and Research (IISERs), and other national level stand-alone institutions funded by Government.

2. All universities/HEIs/employers in the state shall recognize the BS/MS degrees of IISERs, IISc, State/Central Universities, and other HEIs funded by the Government.
3. No equivalency/recognition shall be insisted upon for degrees obtained from National Institutes like Indian Institutes of Technology (IITs), Indian Institute of Science (IISc), National Institutes of Technology (NITs), Indian Institutes of Science Education and Research (IISERs) or other institutions recognized by University Grants Commission (UGC).
4. There shall be reciprocal recognition of degrees awarded by the Indian Universities/other HEIs as listed out and updated by the University Grants Commission.
5. Universities/HEIs/Employment Agencies/Employers in the State shall follow the nomenclature of degrees prepared and listed by the UGC.
6. Universities/HEIs/Employment Agencies/Employers shall follow the conditions, policies and procedure stipulated by Association of Indian Universities (AIU) for according recognition/equivalence of qualification / Degrees awarded by Foreign Universities.
7. Universities/HEIs/Employment Agencies/Employers shall approve/ recognize Degrees acquired through Open and Distance Learning complying with the latest University Grants Commission Open and Distance Learning Regulations.
8. Equivalency/Recognition of Degrees acquired through Open and Distance Learning before the promulgation of the UGC Open and Distance Learning Regulations, 2017 shall be decided by the university concerned.
9. Universities/HEIs/Employment Agencies/Employers shall approve/ recognize Degrees awarded by Private Universities with the recognition/approval of the UGC, and which comply with the relevant UGC norms/regulations as amended from time to time.

The Governing Body further resolved to recommend to the government to establish a State Level Academic Committee (SLAC) in the Kerala State Higher Education Council (KSHEC) for the purpose of disposing of objections/disputes/complaints regarding the nomenclature of Academic Programmes/Degrees and according approval/recognition/ equivalence. Universities/HEIs/Employment Agencies/Employers shall refer unsettled issues of nomenclature of Academic Programmes/Degrees and their approval/recognition/equivalence to KSHEC for decision by the SLAC. In all issues of nomenclature of Academic Programmes/Degrees and their approval/recognition/equivalence the aggrieved candidates shall appeal to the KSHEC for the decision by SLAC.

## Additional Agenda

### Item No. A1 Inter University Centres (IUCs).

Approved the Interim Report with modifications on the functioning of Inter University Centres in state Universities presented by the Chairman of the Committee  
Prof. Rajan Gurukkal.P. M.

#### a) Observations:

1. One of the IUCs at CUSAT, which deals with Intellectual Property Rights and Patents, has been consistently performing well all along and as an inter-university centre of multi-institutional clientele. One in Nano-technology has been inactive for the past seven years and has started functioning. Another Centre dealing with Kerala Mathematics received only a small amount and its performance has not been noteworthy. In Kannur University, its only IUC has been performing well. MGU has the maximum number of IUCs (nine) and the one for Nano-science and Nano-technology ranks foremost in achievements. That is the only international inter-university centre. Others have been active but with uneven outcomes. Of the six IUCs of Kerala University the one dealing with Bio-informatics ranks foremost. It is functioning as an inter-university centre of cross-disciplinary and multi-institutional character. Others are not in the avowed track as yet.
2. Most IUCs do not have their Governing Council.
3. All universities have been largely supportive of their IUCs.
4. MG University's approach has been strikingly intrusive for the last three years and in various ways opposed to the construed spirit of autonomy. It indiscriminately changed the Directors of IUCs as an administrative imposition from above and with utter disregard for academic specialization, the most essential qualification. Such outrageous interferences have not been reported from any other university.
5. In the Calicut and Kerala universities specialists themselves decided to change the headship of IUCs by turn. In Kannur the Director continues even after the incumbent's retirement.
6. It is mandatory that all the host universities understand the concept, objectives and scope of the IUC and comply with the stipulated norms.


#### b) Suggestions/Priorities

1. It should be mandatory that the teaching/research faculty member with the required specialization, who designed and proposed the Centre or his/her nominee with specialization or the specialist nominated by the Executive Committee, becomes the Director of every IUC.
2. The present Governance Structure of the IUC is top-heavy and tripartite, which is unnecessary and impractical. Its governance must be bestowed upon the Executive Body consisting of the Academics and presided over by the Vice Chancellor of the University concerned.
3. It is not practical for Ministers/the Chief Minister to be heading the Governing Council of each IUC and putting such great Offices in charge of small organizations, mostly less than regular Department of the University, is inappropriate. Instead, it may be appropriate to have them at the helm of Governing Council common for all the IUCs in the state.
4. It is important that all IUCs have their own structural pspace.
5. Every IUC should have separate budgetary allocation.
